Touching the Lives of Texans

THROUGH OUR SIGHT SAVING PROGRAMS AND SERVICES

Focused on providing a continuum of vision care, Prevent Blindness Texas touches the lives of thousands of Texans through our network of volunteers and regional offices.

Only one in three children in America receives eye care services before the age of six.

WE WANT ALL CHILDREN TO BE "STAR PUPILS"



Because one out of three children in the United States does not receive critical eye care services before the age of six, many children are at risk of suffering vision loss. Prevent Blindness Texas launched its "Star Pupils" campaign, the organization's children's platform, designed to educate parents on children's vision issues. The campaign also seeks donations to provide disadvantaged children with access to vision care.

The "Star Pupils" campaign arms parents with information they need in order to protect their kid's eyes at play and school to ensure a lifetime of quality vision.

Parents may simply visit starpupils.org to receive free sight-saving information about their child's eye including information on Common Eye Problems in Children, Eye Safety, and a Family At-Home Vision Test.

Starpupils.org also provides useful information for parents of school-age children. Parents are also encouraged to share stories of how their child's vision health has impacted their lives. Without a certified vision screening or eye exam, a child may have serious undetected vision problems. In fact, some potentially blinding eye diseases and conditions can be successfully treated if detected early in life. Possible vision conditions in children include amblyopia, or "lazy eye," strabismus, or "crossed eyes". Amblyopia is the most common cause of visual impairment in childhood and is responsible for more loss of vision in people age 45 and younger than all other eye diseases and trauma combined.

According to vision industry statistics, 80 percent of children diagnosed with a learning disability have an undiagnosed vision problem. And, 70 percent of juvenile delinquents have visual problems.

Only an eye doctor can diagnose and treat a vision problem, but vision screenings help find children and adults who need a full eye exam. Prevent Blindness Texas' vision screenings are an accurate, cost-effective way to find vision problems and refer people with signs of problems to eye doctors for professional care.

Through our educational platforms and partnerships, including the "Sight for Students", "Healthy Eyes Eyeglass" and "Partners in Prevention" programs, Prevent Blindness Texas provided eye health information to more than 75,264 Texans and direct eye care services to 941 children and 8,806 adults.

Through the "Healthy Eye Eyeglass" Program, Prevent Blindness Texas partnered with OneSight to provide vouchers

for free eyeglasses to children and adults in need identified by Prevent Blindness Texas staff. The program vouchers can be used at any participating LensCrafters, Sears Optical, Target Optical, or select Pearle Vision locations.

In partnership with OneSight's program, Prevent Blindness Texas distributed more than 3,411 vouchers for free eyeglasses to low income families in need of eyeglasses in Fiscal Year 2010-2011. This project, the National Vision Preservation Initiative, involved multiple parties across five separate, yet integrated components. Continue to Evolve


Every 11 minutes, someone goes blind. Prevent Blindness Texas worked in partnership with the Texas Department of State Health Services (TDSHS) Office of Border Health on the Texas Vision

Health Integration Project. The project held its first Texas Vision Health Integration Collaborative (TVHIC) meeting in September 2010 with 35 internal TXDSHS and external partners in attendance. This collaborative provided direction to the three TVHIC workgroups: Early Detection and Prevention, Workplace and School Safety Injury Prevention, and Education and Community Outreach.

THE ORGANIZATION

PREVENT BLINDNESS TEXAS PLANS FUTURE OF ORGANIZATION

In summer 2010, the Board of Directors voted and agreed upon the reorganization of Prevent Blindness Texas into four regions. These regions included the Northeast, Northwest, Southeast, and Southwest Regions, based out of Dallas, Fort Worth, Houston and San Antonio, respectively, as well as two offices located in Midland and Lufkin. Each regional office was staffed with a Regional Director and Program Director. The offices located in Midland and Lufkin was staffed with a Program Director. As shown in the table on the right, each region would be responsible for expanding our sightsaving programs and services in their designated region.
